



## Annual Report Fiscal Year 2016 – 2017 MGPUB grant proposal number 2017165

## **Overview**

The following sections of this report highlight activities of the National Barley Growers Association for the period July 1, 2016 – June 30, 2017.

## **Current Projects and Activities**

NBGA focused on the following topics and activities for the above referenced reporting period:

- Current Projects
  - Opposing the implementation of the Waters of the United States (WOTUS) / Supporting the March 6, 2017 EPA & USACE announcement to review and rescind or revise WOTUS.
  - Supporting and petitioning the rules making process for the national labeling standard for GMO products
  - Pesticide registrations
  - Continued implementation of the new Malt Barley Endorsement crop insurance policy; available in 2016. The new insurance product (which was proposed to USDA-FCIC by the North Dakota Barley Council) provides insurance coverage for malting barley based upon malt barley quality attributes. While growers are now able to insure their barley for the appropriate prices relative to the type of barley being produced on their farm and includes settlement data from the industry to assist in developing appropriate premium rates; additional revisions are needed to ensure adoption by growers.
  - Continued efforts to reform beer excise taxes through support of the Craft Beverage Modernization and Tax Reform Act of 2017.
  - Supported unsuccessful efforts to pass the Trans Pacific Partnership free trade agreement / Petitioning the Administration to not withdraw from the North American Free Trade Agreement.
  - Supporting as a member Field to Market and contributing to the development of sustainability metrics for barley production
  - Support of the \$2 million funding increase for the Wheat and Barley Scab Initiative in the final FY 2017 Omnibus bill, and continuation of the funding increase in the FY 2018 Appropriations bill.
  - Developed barley priorities and petitioning Congress for passage of the 2018 Farm Bill.
- Current Activities
  - NBGA board meetings (2 per year). NBGA met in February 2017 in Washington DC, and in June 2017 in Minneapolis MN.
  - Barley, Boots, and Brews. NBGA hosts this reception on Capitol Hill during the winter NBGA meeting in Washington DC. The reception is well attended and provides an opportunity for relationship building with Congressional staff and NBGA stakeholders.
  - NBGA revised its bylaws in February, 2015 to include industry representation on the Board of Directors. In June, 2016, in a continuing effort to encourage more participation from member states and to cultivate future barley grower leaders, NBGA adopted a budget that included \$22,500 to continue the policy of paying travel expenses for one representative from each state grower organization to attend NBGA meetings and \$15,000 for the continuation and expansion of the "Barley Industry Leaders of Tomorrow" (BILOT) program, bringing young growers from member states to attend the biannual meetings. A BILOT "AgVocate" all day training session, sponsored by

Bayer Crop Science, is planned for February 4, 2018 in Washington DC, prior to the Feb 5-7 winter meeting. Member states are encouraged to send 2 BILOTs to this training and subsequent meetings, and other board members and staff are welcome to attend.

- Grower Board members from Colorado and Wyoming have joined the Board of Directors, with dues being paid by MillCoors. Attended meetings in Colorado and Wyoming in support of forming state barley grower organizations.
- Attended the Craft Brewers Conference in Washington DC to further relationships with the growing craft beer industry.
- Efforts to bring in additional Industry Members to the NBGA continue and have been successful. BNSF has joined this past year.
